

Terms and conditions of use

1. Introduction

- 1.1 These terms and conditions govern your use of our website.
- 1.2 By using our website, you accept these terms and conditions in full; accordingly, if you disagree with these terms and conditions or any part of these terms and conditions, you must not use our website.
- 1.3 If you submit any details to our website or use any of our website services, we will ask you to expressly agree to these terms and conditions.
